CONDITIONS FOR PARTICIPATION IN THE DEGUSTATION CONTEST "GOLD BREWER'S SEAL 2020"

1. The binding application form must be sent to the following address by **31 December 2019**:

2. All types of degustation samples of volume of 7 liters (in glass, metal or plastic packaging) must be delivered to the following address by **15 February 2020** at the latest:

3. **The fee of EUR 30** per type of beer registered for the contest / microbreweries: EUR 20 / to be paid by transfer to **account** kept with **Fio banka 238 147 379/2010**

according to the maturity of the respective invoice for the samples registered, or in cash before commencement of degustation subject to agreement as to the change.

4. **The contest WORLD BEER SEAL 2020** is subject to the conditions specified below:

- **no worse than the third position** in any category **in the year 2020** and based on the organizers' recommendation, if any

- **registration orally or electronically by the brewery's authorized officer after the given degustation category finishes**

- consent to payment of the contest participation fee in the amount of EUR 30 per sample registered, according to the respective invoice issued

The winner will be conferred the right to use the title and mark "**GOLD BREWER'S SEAL 2020**", or, as the case may be "**WORLD BEER SEAL 2020**".

Only the placings of finalists of the individual contests will be announced.

INFORMATION FOR PARTICIPANTS IN THE PUBLIC PART

The public part of the festival will be opened for visitors from 20 to 22 February 2020 in the exhibition grounds [Výstaviště] České Budějovice, Pavilion T1, České Budějovice. The opening hours of the public part are from 16:00 to 24:00 hours every day. During these three days, approximately 5 thousands of visitors are expected. We will provide breweries and business companies, at their request, with premises for commercial and non-commercial presentation of their products. Lease of areas for presentation, sales, draft or degustation bars or an exhibition area is subject to the contractual price: EUR 20 per 1m² + services.

Presentations on a smaller scale can be arranged for microbreweries and cider producers, at their request, for a pro-rata portion of the rate.

Preparatory work in the agreed area can be carried out beginning from 19 February 2020. The area must be vacated within 24 hours of the end of the event.
